



WHY PAY \$750 IN TAXES TO THE STATE OF OHIO WHEN YOU CAN DESIGNATE THAT MONEY TO BENEFIT ST. HELEN SCHOOL?

1) TAX CREDIT OPPORTUNITY FOR EVERY OHIO RESIDENT

Ohio taxpayers can receive a **100% tax credit** (up to \$750 per individual or \$1,500 per married couple filing jointly) when contributing to a certified scholarship granting organization (SGO).

Redirect your tax dollars to support students at **St. Helen School** instead of sending them to the state.



2) CHECK YOUR TAX RETURN FOR ELIGIBILITY

Review your **Ohio IT 1040** form to confirm your state tax liability. If you owe at least \$750 (or \$1,500 jointly), you can claim the full credit. **Example:** If you owe \$750 or more in Ohio taxes and donate \$750 to the fund, your tax bill is reduced by \$750 — a **dollar-for-dollar credit!**



3) MAKE A CONTRIBUTION TO ANGEL SCHOLARSHIP FUND

Scan the QR code below and select "St. Helen School" as the beneficiary. Contributions must be made by **April 15**, to apply toward your 2025 Ohio taxes.



4) GET YOUR CONTRIBUTION BACK VIA TAX REFUND

When filing your Ohio tax return, claim the "Scholarship donation" tax credit when you file your Ohio State income taxes. Your contribution amount will be **refunded or credited** against your state tax liability!



5) SCHOLARSHIPS AWARDED TO ST. HELEN STUDENTS

Your contribution directly supports scholarships for students at St. Helen School, helping all families receive a \$0 tuition commitment!
